The Department of Education regulations for leave of absence will be followed by \$t \$\text{Simon}'s including that: Parents who take their child/children on holiday in school time may be referred to the Education Welfare Officer who decides whether a Fixed Penalty will be issued. Fixed Penalty of £60 per adult, per child may be enforced this increases to £120 if not paid within 21 days but if paid between 22 and 28 days. Failure to pay Fixed Penalty may result in prosecution in Court. Other unauthorised absence or persistent issues regarding punctuality may also receive a Fixed Penalty.
